The OSD has developed ten criteria to determine whether a licence for software program is open supply (see Fig2.).

1. <b>Free redistribution:</b> the software to be available for distribution without payment.
2. <b>Source code:</b> the soft to be distributed with the source or well-publicized access to it.
3. <b>Derived works:</b> the license must allow modifications and derived works, and must allow them to be distributed under the same terms as the license of the original software.
4. <b>Integrity of the author's source code:</b> distribution of "patch files" used to recreate derived works to be permitted.
5. <b>No discrimination against persons or groups:</b> the license must not discriminate against any person or group of persons.
6. <b>No discrimination against fields of endeavour:</b> for example, it may not restrict the program from being used in a business, or from being used for genetic research.
7. <b>Distribution of license:</b> the rights attached to the program must apply to all to whom the program is redistributed without the need for execution of an additional license by those parties.
8. <b>License must not be specific to a product:</b> license rights must not depend on the software being distributed with the other specific software.
9. <b>License must not restrict other software:</b> the license must not place restrictions on other software that is distributed along with the licensed software.
10. <b>License must be technology-neutral:</b> No provision of the license may be predicated on

any individual technology or style of interface.
