Maya Angelou wrote on the theme of submissive role of women in the society in her poem "I know why the caged bird sings" expressing the desire of woman to come out of the imposed limitations and sing as a free bird. Her poem "Phenomenal woman" glorifies women as a phenomenal being. It has the themes of womanhood, identity, pride and self- acceptance. In one poem she brings out the adverse circumstances that compel woman to be in limitations and in the other she shows that women herself can come out of the cage through her self-confidence.

I Know Why the Caged Bird Sings, is the first of seven autobiographical works by American writer Maya Angelou, published in 1969. The predominant theme of the poem is freedom. The first line depicts this by introducing "the free bird." singing happily whereas the caged Bird longs for freedom from imprisonment. A caged bird in captivity "sings of freedom."

A free bird claims the sky to be its domain, it flies soaring the sky with happiness on its complete liberty. Contrary to this the caged bird is longing for the things that it is deprived of, it sings for freedom and the echoes of its painful survival are heard in the distance, its wings are clipped and its feet is tied as if it is standing on the grave of its dream as deprived of freedom, it can't fulfil its dreams to rise in the sky.

"Phenomenal Women" is a poem by Maya Angelou, first published in 1978. The poem celebrates womanhood, quest of self-identity, pride, self-love, and self-acceptance. It's a didactic poem giving the message that empowerment comes from within, from your own self. This poem emphasises that beauty is not a condition to be a phenomenal woman; it rejects the expected role of women in the patriarchal society and focuses on an alternative perspective of the definition of real beauty. It focuses on the Self- confidence and comfort of being a person you are, the speaker insists are the markers of true beauty. The line, "I'm a woman" propagates her self-confidence in being a woman. She celebrates not only her physical beauty but also her inner glow.

She explains that "pretty women" often look at her and wonder what makes her so attractive and alluring. The speaker says she is unlike these conventionally-beautiful women; she is not "cute" and does not possess a model's figure. But she has a very powerful presence.

However, she claims that when she tries to explain her allure to these women, they never believe her. The speaker insinuates that they may be incapable of believing that a woman who does not fit conventional standards of beauty can be beautiful at all. The speaker concludes the stanza with a refrain about being a "phenomenal woman." She proclaims with pride that she is not merely a lovely woman, but an exceptional one. The speaker proceeds to describe her effect on men. She explains how she draws their attention whenever she walks into a room. Each time she walks before them calmly and confidently, they either stand up at her arrival or melt from their desire for her. They try to captivate her attention.

The stanza concludes with the refrain of being a phenomenal woman, once again reaffirming the speaker's confidence and justifying other people's reactions when they notice her.

However, she takes her analysis to another level when she suggests, that she possesses another kind of beauty altogether. She has a mysterious inner beauty that men cannot see or understand even when she tries to show them. They are blind to what makes a woman beautiful from within, as they only judge her based on her physical looks.

The Literature written by women writers depicts the concealed facts of life through women's perspective. We, women are phenomenal in different ways, but this beauty is visible only to the eyes of the beholder.
